ANNUAL REPORTS.

PRESIDENT'S REPORT.

Ladies of the Century Club of California:

Among the many fallacies to which human nature is prone, one of the most common, perhaps, is the supposition that where there is no noise there is no progress. True progress, however, does not necessarily imply either noise or excitement; on the contrary, these generally create confusion, and are a great hinderance to real growth.

In order to ascertain whether or not progress has been made, it is necessary, and may be instructive, to glance back over the past year and see whether we have advanced, or whether we remain *in statu quo*.

In order to secure the steady growth of the Club toward perfection, it has been the policy of the administration to secure the services of those who, by their experience or aptitude, were best qualified to promote, not the improvement, however desirable, of the members individually,

but the development of the Club itself as an institution.

Bearing in mind the fact that every growing body, in order to secure its harmonious development, requires variety of nourishment, and remembering that our members, like the poor, were always with us, the committees were encouraged to secure from outside sources such material as, in their judgment, was best fitted to awaken interest and afford instruction.

The program of exercises of the Art and Literature Committee for the past year has been both refined and elevating.

Upon practical questions of the day, nothing has ever equalled the remarkable discussions the Club has listened to upon high license.

The papers on the Chemistry of Plants and Single Tax serve as an example of the new subjects introduced by the Committee on Science and Education.

The days devoted to music have, by their variety and general excellence, aroused an interest and enthusiasm far surpassing anything previously given.

Our social days also have been an unqualified success, and the dainty menu and graceful

service provided by the Entertainment Committee calls for special mention and grateful thanks.

Our domestic affairs have moved with the same smoothness and regularity as heretofore, and the good feeling between our tenants and ourselves, which began two years ago, remains unchanged.

It will be seen by this résumé that each committee, while keeping within its own limits, has opened up to us, as a Club, new lines of thought, or presented old subjects in new and attractive lights.

Our knowledge of parliamentary forms has become more exact, our social life has been full of promise, and a general spirit of symmetrical progress has to the discerning mind been clearly visible.

As regards the present status of the Club, the administration of the past year would say that it leaves the Club with the limits of its membership almost reached; more than money enough in the bank to pay the rent of the clubhouse for the entire coming year; a record behind it for honest work and honesty of purpose which will bear the fullest examination, and the

consciousness of having devoted itself to what it believed to be the best means of securing the permanent establishment of a Club which, by the diversity of members, the harmony of its life, and the purity of its ideal, should stand in the community as a living monument to all that is noble and beautiful in womankind.

CORRESPONDING SECRETARY'S REPORT.

Mrs. President and Ladies:

As I sat last evening considering how succinctly or how expansively I should obey the behest of our Constitution in presenting an Annual Report, it amused me to reflect in how few words one might really convey all the facts which, as a member of a great feminine Guild, I was about to darken with much counsel. Then I recollected an instance where, in face of an august assembly something like ours, succinctness was carried to a very fine point indeed.

It said that a celebrated Scotchman, returning from beyond seas, was, in recognition of distinguished public services, to be received with special honor by the convivial club to which he belonged and to be made the recipient of a speech of welcome and an elegant silver goblet.

To render the occasion more effective, the presentation oration was to be delivered by a

friend of the hero's boyhood whose sober footsteps, however, had never learned to stray beyond the breezy confines of the rural shades. That there might be no *contretemps*, the recipient was made thoroughly acquainted with the intended speech of welcome and encouraged to prepare an answer of corresponding elegance, which he did, point for point.

The great day came; the goblet, richly chased, reposed on a salver between the two speakers, who, carefully coached, faced each other amid the expectant assembly. But, alas! the rural spokesman was so overwhelmed with excitement and embarrassment that not one word could he remember; he hem'd and haw'd, shifted painfully from one foot to the other, and finally stood speechless and gasping.

The respondent was of course equally non-plussed; how could he comment admiringly on what had never been said? At last, I suppose, the assembly faded from the eyes of both of them; each saw only the playmate of his ragged boyhood, and with the one desire to deliver his old friend from his wretchedness, the guest whispers hoarsely, "Jan, is yan the moog?" Jan, immensely relieved, shouts out, "Ay, Tam,

yan's the moog!"—crams the goblet into the expectant hand of his friend, and the presentation is successfully accomplished without further words!

And this brings me to your correspondent's report, which, stripped like Jan's speech of all unnecessary verbiage, would read: Ten letters received, thirty letters written, besides notices, etc.

This has been a very quiet year in my department. The Eastern women's clubs had all congratulated us during our first years, and we had congratulated them in return, on our respective happy and successful borings; and the reports, conscientiously exchanged, gave all further information necessary. Repeated and insistent letters of your Secretary failed to elicit information concerning any club resembling ours, existing either in England or on the continent of Europe; the Sorosis of Bombay, India, (strange circumstance!) alone seeming to offer a foreign instance of similar enterprise. The ladies' clubs in England are none of them like ours, being instituted for purposes of convenience or philanthropy only, unless they are suffrage societies; not one being devoted to

social and literary intercourse, while absolutely no women's clubs are yet carried on upon the continent.

In home matters, I have only to report some correspondence with the genial and lovely president of our National Federation of Women's Clubs, Mrs. Charlotte Emerson Brown, resulting in the establishment of a system of introduction to the other clubs of the Federation, which, it is hoped, will prove advantageous to such of our members as may visit the East.

This has been, I grieve to say, a year of many bereavements to members of our Club and their families, and in a number of cases, public loss has coincided with private sorrow, or the bolt has struck within the family of one of our directors, making it proper that the sympathy of the Club should be expressed through its Corresponding Secretary, who, indeed, might this year say to her own grief, as the poet puts it :

What sorrow was, thou bad'st her know,
And from her own, she learned to melt at others' woe!

But, on the whole, your Secretary is sensible that the past year has been one of enlarging and improving experience, and she feels that she

cannot more fittingly close this sketch than by expressing her grateful sense of the invariable kindness and consideration which she has received from the President and from every member of the Directory with which it has been her good fortune to be associated; and her best wish for the incoming administration would be that her term may prove to have developed as much respect and affection between the members as your correspondent feels for those of her co-workers with whom she has been most closely connected.

And now it only remains for me to break my staff of office, metaphorically speaking, and while handing the new one to my successor, to echo the old cry, *Le roi est mort; vive le roi!*

CONSTITUTION.

ARTICLE I.

SECTION 1. The name of this Association shall be: THE CENTURY CLUB OF CALIFORNIA.

SEC. 2. The object of this Association shall be: To secure the advantages arising from a free interchange of thought and from co-operation among women.

SEC. 3. The total number of members shall be two hundred ; of which number one hundred and seventy-five shall be residents of San Francisco, and the remaining twenty-five of any other part of the State of California. The Club may also elect honorary members without regard to their residence, the number never to exceed five. Such honorary members may at all times have the same use of the Club-rooms as do the other members thereof ; but they shall not be eligible for office, nor to serve on any committee, nor have the right to vote at any meeting of the Club.

ARTICLE II.

SECTION 1. A President, first, second, third and fourth Vice-Presidents, one Corresponding Secretary and two Recording Secretaries, a Treasurer, all of whom shall be, *ex officio*, Directors of the Club, and six Associate Directors, shall be the officers of this Club, and together shall constitute the Board of Directors, in which shall be vested the government of the Club.

SEC. 2. All the officers named in the foregoing section shall be elected on the first Wednesday in May of each year, in such manner as is hereinafter prescribed, and shall assume the duties of their respective offices at the annual meeting of the Club on the third Saturday of the following September. They shall serve for a term of one year.

SEC. 3. The Board of Directors shall manage the business of the Club in all matters save those specially provided for in the Constitution as coming before the Club itself for adjustment. They are, therefore, empowered to adopt such regulations as they may deem necessary to the proper management of the Club. They shall also authorize all expenditures of money, and

shall create and appoint such agents and sub-committees as in their judgment are needed, and shall fill all vacancies that may occur in any of the elective offices between two annual elections.

SEC. 4. No member of the Board of Directors shall receive compensation; nor shall any salaried agent be appointed from among the members of the Club.

ARTICLE III.

SECTION 1. The President shall preside at all meetings of the Club and of the Board of Directors; shall appoint from the Board of Directors an Auditing Committee of three, and from the Club at large all standing committees, and the Chairman of the Wednesday Committees, such appointments being subject to the approval of the Board of Directors; shall make a report at the annual meeting of the progress and status of the Club; shall have the casting vote in case of a tie on any question in the Board of Directors; shall sign all warrants upon the Treasurer, and in general have a supervision over the affairs of the Club, and see that its rules and regulations are rigidly enforced.

SEC. 2. In the absence of the President, all

her duties shall devolve upon the Vice-President, who stands next in order of numerical precedence.

SEC. 3. The Recording Secretary shall keep a journal of all the proceedings of the Club, and of the Board of Directors, and file all papers and documents which belong to the Club archives.

The Assistant Recording Secretary shall notify members of any meeting of the Club when necessary, notify persons of their election as members, and perform such other duties as the Directors may require.

SEC. 4. The Corresponding Secretary shall conduct the correspondence of the Club, and keep a file of all letters received, and a copy of every important letter written by her. She shall present a report at each regular meeting of the Board of Directors, and an annual report at each annual meeting of the Club.

SEC. 5. It shall be the duty of the Treasurer to receive all moneys belonging to the Club, and to disburse the same, under the direction of the Board of Directors, upon checks or orders signed by the President and one member of the Auditing Committee. She shall deposit the same with

the bank or banks to be designated by the Board of Directors, in the name of the Club.

She shall keep true books of account, accessible at all times to the officers of the Club, shall submit a statement of her accounts at each monthly meeting of the Board of Directors, with proper vouchers; and make an annual report at the annual meeting of the Club.

It shall also be her duty to notify members in case of delinquency in payment of dues, as provided in Article V, Section 1.

SEC. 6. It shall be the duty of the Auditing Committee to examine and audit all accounts and bills as often as the same shall be necessary, but not less than once a month. Before such accounts and bills shall be paid, they must have been first approved by the Chairman of the committee incurring the indebtedness. The signatures of the President and of one of this committee shall authorize payment of bills. It shall be the duty of the Auditing Committee to have all regular bills—such as rent, gas, water, etc.—ready for the President's signature at the regular monthly meeting of the Board of Directors.

ARTICLE IV.

SECTION 1. To become a member of this Association, it is necessary to be proposed by a member and elected by the Board of Directors.

SEC. 2. The President of the Club shall appoint a committee of three, whose names shall be known only to the President, and who shall receive all proposals for membership and pass upon them before submission to the Board of Directors. The name of the candidate proposed must be inclosed in an envelope, with the name of her indorser; and this envelope must be sealed and sent under cover to the President, who must not be informed of the name either of the candidate or her indorser, but shall transmit the sealed envelope to the Committee on Membership.

SEC. 3. Whenever the Committee on Membership shall send the names of any proposed new members to the President, she shall call a special meeting of the Board of Directors, to take place at least two weeks before the next regular meeting of the Board, and at this special meeting shall submit the names of the proposed new members for the consideration of the Board of Directors.

SEC. 4. All letters indorsing candidates, and stating their qualifications for membership, shall, after having been sent to the President by the Membership Committee, and read by the Board of Directors, be placed for one year in the archives of the Club by the Recording Secretary.

SEC. 5. No candidate who shall have failed to be elected shall be again proposed for membership within one year from the date of first proposal.

SEC. 6. The Directors shall vote for candidates for membership by ballot. Nine votes shall be considered a legal ballot, and three black balls shall reject.

SEC. 7. No vote, either of the Club or of the Board of Directors, shall be cast by proxy.

SEC. 8. Every Director shall be in honor bound to keep secret the names of persons proposed until the same shall have been elected to membership; nor shall the name of a defeated candidate ever transpire outside of the Board of Directors.

SEC. 9. No Director shall be at liberty to state the nature of her own vote for candidates for membership.

SEC. 10. Only one successful candidate shall

be proposed by a Club member during one year. On final rejection of a candidate for membership, the proposer shall be immediately notified that she is at liberty to send in a new name.

ARTICLE V.

SECTION 1. Every member shall contribute the sum of twelve dollars for a Club year, which dues shall be paid for an annual term commencing September first, or for semi-annual terms commencing September first and March first. Any member failing to pay her dues within thirty days after the first of September or the first of March shall be personally notified of her delinquency by the Treasurer, and failing to pay such dues for thirty days after such notification shall, *ipso facto*, cease to be a member of the Club.

Personal notice shall be deemed to have been given to any member when mailed to her at her last known address.

On good cause shown, the Board of Directors shall have the power to restore any member who may by such default have lost her membership.

SEC. 2. An initiation fee of twenty dollars shall be required from members elected on or after September 1, 1890. On the election of each

new member, the Assistant Recording Secretary shall immediately notify her thereof, and furnish her with a copy of the Constitution and By-Laws. The Constitution and By-Laws must be signed in the office of the Club, and the initiation fee paid by each new member within thirty days after notification of election ; and any lady not making response either in person or by writing to the notice of her election, within one month after such notice is sent her, shall forfeit her election, and shall not again become a candidate for membership within one calendar year from the date of her first election.

The payment of yearly dues shall begin on either the first of September or the first of March, whichever first follows her election.

SEC. 3. Any member conducting herself, either in the Club or elsewhere, in a way calculated to disturb the harmony of the Club, or impair its good name or prosperity, may be reprimanded, suspended or expelled, as the Board of Directors may decide, subject to appeal to the Club.

SEC. 4. The fee for life membership shall be one hundred dollars, upon payment of which the annual dues shall cease.

SEC. 5. The fiscal year shall begin on the first of September.

ARTICLE VI.

SECTION 1. The annual meeting of the Club shall be on the third Saturday in September, at two o'clock P. M.; and individual notices of the same shall be sent to members by the Secretary at least five days before that date.

SEC. 2. The Board of Directors shall meet once a month; and seven of its members shall constitute a quorum for all business except electing candidates for membership, when nine will be a quorum. Any member of the Board of Directors who shall absent herself, without good cause, from its meetings for three consecutive months, shall be deemed to have resigned therefrom.

SEC. 3. Special meetings of the Board of Directors may be called at any time by the President, either of her own motion or at the request of three members of the Board.

SEC. 4. Special meetings of the Club, to consider specified subjects, may be called at any time by the Board of Directors, and *shall* be called by the President at the written request of ten members of the Club, notice of such special meeting and subject being sent to members five days before date of meeting.

ARTICLE VII.

SECTION 1. At the regular meeting of the Board of Directors in March of each year, the Directors shall elect a Nominating Committee, consisting of seven persons, to be selected from the Club at large; and this Nominating Committee shall prepare a ticket of the officers to be elected for the ensuing year, which ticket shall be printed and circulated for two weeks before the first Wednesday of May, that being the day of election.

SEC. 2. Voting shall be by ballot, the polls to be open at the Club-rooms from two o'clock until five in the afternoon of said day.

SEC. 3. No member shall vote at an annual election until after paying all dues for the year in which the election is held.

SEC. 4. Three judges of election shall be appointed by the acting President,—two from the Club at large, and one from the Board of Directors. Two of these judges shall be present during the whole time the polls are open; and the three together shall close the polls at five o'clock, and shall count the votes. They shall then report the names and votes to the Direc-

tors, who shall at the next meeting of the Club declare the result.

SEC. 5. A plurality of all votes cast shall elect.

SEC. 6. In case of a tie, decision shall be made by lot.

ARTICLE VIII.

SECTION 1. This Constitution may be amended by a majority vote of the quorum required for constitutional amendment at any regular or special meeting. Notice and copy of proposed amendment shall be sent to each member of the Club at least one week before such regular or special meeting.

SEC. 2. Thirty members of the Club shall constitute a quorum for all business except amendment of the Constitution, when fifty members shall be required for a quorum.

SEC. 3. This amended Constitution shall take effect on the fourteenth day of May, 1890; and a special election for the officers to be installed in September, 1890, shall be held on the third Wednesday of August.

The Nominating Committee for this special election shall be appointed at a special meeting of the Board of Directors in May, 1890.

BY-LAWS.

SECTION 1. The President, and in her absence the acting President, shall have the power of issuing cards of invitation to non-residents, and also to distinguished strangers in the city, to any of the regular meetings of the Club (excepting those devoted exclusively to business), provided that not more than twenty such invitations shall be issued for any one meeting, and that each such card shall bear the autograph of the officer issuing it, the name of the guest invited, and the date of the meeting.

SEC. 2. No resident of San Francisco shall be admitted as a visitor to any regular meeting of the Club, except on invitation of the Chairman of the day, who may obtain from the President invitation cards, not to exceed five in number, for any one meeting.

SEC. 3. In all questions arising concerning the construction of the Constitution and By-Laws of this Club, the decision of the Board of Directors shall be final, unless overruled by a two-thirds

vote of the members present, such vote not being taken except after notice of five days given to each member, and not less than fifty members being present.

SEC. 4. A two-thirds vote of those present shall be necessary to close debate or suspend rules.

SEC. 5. All important voting in the Club must be done by ballot, which may be called for by any member.

SEC. 6. This Club shall never request a member to sell tickets; nor shall it arrange any entertainment for the profit or for the charitable relief of any individual or association; nor shall it advertise any business enterprise.

SEC. 7. No demonstration on behalf of any political or religious object shall ever be made by this Club; and sectarian doctrines or political partisan preferences shall not be discussed by this Club at any regular or special meeting thereof.

SEC. 8. The rules and orders of Roberts' Manual of Parliamentary Law shall govern this Club so far as they are not inconsistent with this Constitution.

REGULATIONS.

1. The Club shall meet weekly, on Wednesday afternoons, at three o'clock.
2. The first Wednesday of each month shall be under the charge of the Committee on Art and Literature.
3. The second Wednesday shall be under the charge of the Committee on Practical Questions of the Day.
4. The third Wednesday shall be under the charge of the Committee on Science and Education.
5. The fourth Wednesday shall be under the charge of the Committee on Social Entertainment,—and on that day light refreshment will be served.
6. When a fifth Wednesday occurs, it shall be under the charge of the Committee on Formal Debate.
7. From each committee, with the exception of that on Formal Debate, one Wednesday shall be taken to be under the charge of the Committee on Music.

8. No report of the proceedings of the Club shall appear in print, except by official permission. Members will be held responsible for the observance of this rule by their guests.
9. Members must be ready to show their tickets at the door when required.
